

SELF CERTIFICATION ON TAX RESIDENCY (INDIVIDUAL) FORM

What is this form about?

The Foreign Account Tax Compliance Act ("FATCA") and OECD Common Reporting Standard ("CRS") regulations require Green Link Digital Bank Pte. Ltd. ("GLDB" or "the Bank") to collect and report certain information about our customer's tax residency. If you are a U.S. Person or tax resident outside the country where your account is held, the Bank may be legally obliged to pass on the information in this form and other financial information with respect to your financial accounts to the relevant tax authorities and they may exchange this information with tax authorities of another jurisdiction or jurisdictions pursuant to intergovernmental agreements to exchange financial account information.

This form is intended to request information for the purpose of complying with relevant tax regulations. Please complete this Self-Certification Form so that we hold accurate and up to date information about your tax residence status. If there are subsequent changes to your circumstances, please let us know by providing an updated Self-Certification Form.

4) Notes

¹Definition of "US Person"

- (a) A citizen or permanent resident of the United States (e.g. US Green Card Holder or someone who meets the requirements to be considered a resident under the 'substantial presence test');
- (b) US corporations, partnerships, estates and trusts;

(c) Any other person that is not a foreign (i.e. non-US) person (as defined under US federal tax law).

²Definition of "Tax Resident" Each jurisdiction has its own rules for defining tax residence, and jurisdictions have provided information on how to determine if you are resident in the jurisdiction on the Organisation for Economic Co-operation and Development (OECD) Tax Residency website. In general, you will find that tax residence is the country/jurisdiction in which you live. Special circumstances may cause you to be resident elsewhere or resident in more than one country/jurisdiction at the same time (dual residency). For more information on tax residence, please consult your tax adviser or the information at the OECD automatic exchange of information portal mentioned above.

³TIN is a unique combination of letters or numbers assigned by a jurisdiction to an individual and is used to identify the individual for the purpose of administering tax laws of such jurisdiction.

incorrect or incomplete, and to provide Green Link Digital Bank with a suitably updated self-certification
